The Trustees in and for the Geary Utilities Authority met on the above date for their regular meeting. In accordance with the open meeting law, the agenda and meeting notice were posted on the window of City Hall, 115 S. Broadway, before 5:00 o'clock pm, on Wednesday, January 6, 2016.

Chairman, Bobby Allen, called the meeting to order at 7:52 pm. Those answering roll call were Ernest Allen, Leslie Swinerton, Ronnie Wheeler, Cozetta Johnson, and John Gregerson. Also present were City Attorney Raymond Vincent, Public Works Director Jeff Choate, residents Lois Nofsinger, Elisha Bingham, and Linda Bingham.

Randy McClure, with McClure Management Consultants, LLC, was not present to discuss the possibility of getting a long term loan to consolidate the costs for replacing and or repairing gas, water, and electric service lines. No action was taken.

Jeff Choate presented the board with the monthly activities for the utility authority. The employees have been doing a lot limb removal and repairing down power lines due the two (2) ice storms. We had a lot of ice damage on November 27, 2015, with the power blinking on and off for over a seven (7) day period. Then another storm came through on December 27, causing more tree damage. The power was off for at least 48 hours due to damage to the incoming lines. The water well computer system was damaged by this storm. Jeff has been in contact with the county and state emergency management group to survey our damages for FEMA support. The FEMA team and members of the Oklahoma Emergency Management team met with Jeff today and have determined that we will qualify for FEMA assistance. They also took the needed paperwork for the first 30 days. The first 30 days will be reimbursed at 85% with a check back to the city in the near future.
