The Trustees in and for the Geary Utilities Authority met on the above date to reconvene their regular meeting. In accordance with the open meeting law, the agenda and meeting notice were posted on the window of City Hall, 115 S. Broadway, before 5:00 pm Wednesday, February 8, 2017.

Chairman, Bobby Allen, called the meeting to order at 6:15 pm. Those answering roll call were John Gregerson, Ronnie Wheeler, Leslie Swinerton, and Ernest Allen. Cozetta Johnson came in at 6:40 pm. Also present were City Attorney Raymond Vincent, Public Works director Jeff Choate, Linda Stuard, Loice Nofsinger, and Elisha Bingham.

Ronnie Wheeler made the motion seconded by Ernest Allen to pay Powell Service, Inc. for laying four (4) miles of four (4) inch water line north of town. This bill is to be paid out of the Construction Fund, with the NODA grant money deposited into the GUA Fund, then transferred to the Construction Fund. Ray is still negotiating for a water agreement with the Levi heirs.

Cozetta Johnson made the motion seconded by John Gregerson to approve the monthly public works report. Ayes: Ernest Allen, Leslie Swinerton, John Gregerson, and Cozetta Johnson. Nays: None.

Powell Service Inc. was to lay a four (4) inch water line four (4) miles north of town. The city ordered the water line that was to be used, but miss calculated the amount of line that would be needed. The contractor ran out of line about 500 feet before the intersection. Jeff ordered more water line, that the city will install, and requested that he be allowed to cross the blacktop road and extend the water line east at least another 500 feet on the south side of the east bound blacktop road. This would allow the city to connect two (2) more housed to this line. Leslie insists that the NODA Grant was for water line to the intersection and no further.
