Leslie Swinerton made the motion seconded by Ronnie Wheeler to approve Ordinance #2015-03 adding sections 11-220 through section 11-225 of the Code of Ordinances of Geary, Oklahoma creating a Park and Recreation Advisory Board; designating members of the Park and Recreation; setting forth procedures; providing for absence from meeting; providing for duties; providing for trustees of donations; declaring repealer; providing for severability; and declaring an emergency. Ronnie Wheeler made the motion seconded by Leslie Swinerton to go into executive session at 6:50 pm, pursuant to Title 25, Section 307-B1, for the purpose of hire, fire, promote, demote, discipline, or resignation of library part time employee, pool manager, and lifeguards. Leslie Swinerton made the motion seconded by Ronnie Wheeler to reconvene the regular session at 7:17 pm. Ayes: Ernest Allen, Ronnie Wheeler, and Leslie Swinerton. Nays: None.

Ronnie Wheeler made the motion seconded by Leslie Swinerton to hire Brook Bernhardt as the 2015 summer pool manager at a wage of \$8.00 per hour. Brook will have the authority to hire up to 6 lifeguards. Lifeguards to be paid \$7.25 per hour. All lifeguards must have their lifesaving certificates before starting work. Leslie Swinerton made the motion seconded by Ronnie Wheeler to hire Cailyn Brown as a part-time library assistant at \$7.25 per hour and to not hire Montana Allen as a part time library assistant. Bobby Allen will have the authority to temporarily hire a part time library assistant upon the recommendation of the library board, to be approved by the council at the next regular meeting. No action on the monthly bank balances or the direct deposits for the month of April.

Ronnie Wheeler made the motion seconded by Ernest Allen to approve the consent agenda as follows: approve the encumber \$47,075.79 for the May payrolls, release the General Fund checks in the amount of \$301,187.89, and to pay the Street and Alley bill for \$793.12. Ayes: Leslie Swinerton, Ernest Allen, and Ronnie Wheeler. Nays: None.

Ernest Allen made the motion seconded by Ronnie Wheeler to approve the April 9th, 16th, and23rd minutes. Ayes: Leslie Swinerton, Ronnie Wheeler, and Ernest Allen. Nays: None.

Ronnie Wheeler made the motion seconded by Leslie Swinerton to elect Lindsey Grigg and Craig Stephenson to the Board of Trustees of the Oklahoma Municipal Assurance Group for 3 year terms. Ayes: Ernest Allen, Leslie Swinerton, and Ronnie Wheeler. Nays: None.

More research is needed to find the exact date on when Chief Cornerstone Church moved into the old Mennonite Church building.

Leslie Swinerton made the motion seconded by Ernest Allen to send a letter to Eric Hicks for the removal of a dilapidated mobile home located at 304 W Winnview. Proper procedures are to send a letter with a hearing date to have the removal completed by. If the nuisance is not removed by the hearing date, further action will be taken at that time. Ayes: Ronnie Wheeler, Ernest Allen, and Leslie Swinerton. Nays: None.

<u>New business</u>: Tony Hicks is moving back to Geary. He is planning to move his mobile home to lots he owns on South Rock Island. He is asking to be allowed to leave his home connected to propane fuel for heat and cooking, and to be allowed to fill in the ditch on the west side of his property allowing for full access to the front of the property. Our ordinances do not allow for these requests.

There are some properties in need of building removal and mowing of high weeds and grass that are listed as estates. A letter will be sent to the property owner and the estate manager.

There appears to be a water leak at the new fire station site, Jeff will look into this and take the necessary action.

Leslie suggested adding work order forms to the web site for customers to fill out and send to mayor and the public works director.

There being no further items to discuss, Ernest Allen made the motion seconded by Ronnie Wheeler to adjourn the meeting at 7:56 pm. Ayes: Leslie Swinerton, Ronnie Wheeler, and Ernest Allen. Nays: None.
