The Council Members in and for the City of Geary met on the above date for a special meeting. In accordance with the open meeting law, the agenda and meeting notice were posted on the window of City Hall, 115 S. Broadway, before 12:00 pm Tuesday, July 8, 2014.

Bids were received for the demolition of the building located on the east side of the 100 block of North Broadway. (The site for the Family Dollar Store). C.E. Barker submitted a bid to demolish the buildings and haul the debris away for a cost of \$27,000.00 and Erick Cowan submitted a bid to demolish the buildings and haul the debris away for a cost of \$24,800.00 or \$32,400.00 if the structure contains steel.

Tabbitha Kiener made the motion seconded by Cozetta Johnson to accept the bid from C.E. Barker for the demolition of the buildings subject to the property closing. Ayes: Bobby Allen, Ernest Allen, Cozetta Johnson, and Tabbitha Kiener. Nays: None.

Tabbitha Kiener made the motion seconded by Cozetta Johnson to amend the June 5th minutes concerning the employee policy and procedures manual changes. Remove the nepotism changes and add 25 feet from city buildings to the Smoke Free Workplace section. Also change the personal time to: pay 8 hours as a holiday pay on the June 30th and December 31st. Ayes: Ernest Allen, Bobby Allen, Cozetta Johnson, and Tabbitha Kiener. Nays: None.

Cozetta Johnson had to leave at 1:45 pm.

Tabbitha Kiener made the motion seconded by Bobby Allen to reconvene the regular session at 3:21 pm. Ayes: Ernest Allen, Bobby Allen, and Tabbitha Kiener. Nays: None.

Tabbitha Kiener made the motion seconded by Bobby Allen to hire Bob Reese as a permanent part time building inspector at a rate to be determined later. Ayes: Ernest Allen, Bobby Allen, and Tabbitha Kiener. Nays: None.

No action on the progress of the Family Dollar Store.

No action on a letter from the State Fire Marshalls Office.

Ernest Allen made the motion seconded by Bobby Allen to authorize the Rabies Prevention shots for the animal control officer, Jarod Hicks, at a cost of \$660.00. Ayes: Tabbitha Kiener, Bobby Allen, and Ernest Allen. Nays: None.

Ernest Allen made the motion seconded by Bobby Allen to approve sending the Animal Control Officer, Jarod Hicks, to the Annual Animal control officer training for July 28th through August 8, 2014, in Shawnee, Oklahoma, for a cost of \$375.00. Ayes: Tabbitha Kiener, Bobby Allen, and Ernest Allen. Nays: None.

Bobby Allen made the motion seconded by Tabbitha Kiener to adjourn the meeting at 3:51 pm. Ayes: Ernest Allen, Tabbitha Kiener, and Bobby Allen. Nays: None.
