The City and Beulah Land Church have been in negotiations to trade properties. The abstracts and titles have been brought up to date and City Attorney Raymond Vincent will review them for discrepancies. During the research on the titles, it was discovered that a judgment had been attached to the church property in the amount of \$8,000.00.

Cozetta Johnson made the motion seconded by Bobby Allen to sell the City's property to Beulah Land Church for the title and abstract of their property and \$4,000.11 dollars payable at \$200.00 per month. The police department has property seized from some drug arrests. At this time there is no policy in place to manage seized property. This will be discussed at the March 5th meeting.

Tabbitha Kiener made the motion seconded by Cozetta Johnson to approve the monthly police report with one name correction. Ayes: Ernest Allen, Bobby Allen, Cozetta Johnson, and Tabbitha Kiener. Nays: None.

Copies of the Police Policies and procedures amendment will be distributed to the council for review and place on the agenda for the March 5th meeting.

The Community Improvement Plan extension application was approve until June 2015.

Finding a location for a school farm project will be discussed at the March meeting.

An Ordinance to set a policy for underground electrical wiring will be discussed at the March meeting.

Elisha Bingham was instructed to remove high weeds, grass, trees, and debris from her property last fall. To date this has not been done. Cozetta Johnson made the motion seconded by Tabbitha Kiener to have the Code Enforcement Officer to write a ticket to Elisha Bingham for maintaining an unhealthy environment and to appear in the City Municipal Court before Judge Stephen Haynes.
