GEARY UTILITIES AUTHORITY MEETING MINUTES July 6, 2015

The Trustees in and for the Geary Utilities Authority met on the above date for their regular meeting. In accordance with the open meeting law, the agenda and meeting notice were posted on the window of City Hall, 115 S. Broadway, before 5:00 pm, on July 2, 2015.

Chairman, Bobby Allen, called the meeting to order at 6:02 pm. Those answering roll call were Ernest Allen, Leslie Swinerton, and Cozetta Johnson. Ronnie Wheeler was unable to attend this meeting. Also present were City Attorney Raymond Vincent, Police Chief Waylan Upchego, Public Works Director Jeff Choate, Police officer Cecil Harrall, Fireman Jim Shelton, City accountant Linda Woodruff, payroll clerk Jeremy Springer, David Cottingham with DC Associates Engineering, Millie Vance Grant Administrator, Travis Harrison and daughter Jaycee, Melba Nance, Thomas Lewis, Chad Houchin, and Teresa Hicks.

Travis Harrison was here to discuss possible lowering the natural gas pressure coming into town from the gas receiving station north of town. Currently the incoming gas pressure is over 90 pounds per square inch (90 psi) and could be lowered to 60 psi without hurting the whole town pressures. The town gas lines are set at 24 psi.

Approve the transfer of \$20,834.00 from the GUA to the General Fund. Approve to pay \$1,000.00 to the Economic Development Authority.
