The Oklahoma Water Resources Board (OWRB) is implementing a groundwater monitoring program to characterize the water quality and groundwater levels in Oklahoma's Aquifers. The city received a letter asking for our permission to be included in the program.

Leslie Swinerton made the motion seconded by John Gregerson to allow the State of Oklahoma Water Resources Board permission to take a water sample from a city owned water well located in Section 13, Township 14N, Range 10W located in Canadian County. Fund in the amount of \$5,212.80. Approve the transfer of \$7,750.00 to the Construction Fund. Approve the transfer of \$20,834.00 to the General Fund. Approve to pay the Economic Development Authority \$1,000.00, and to pay the United Energy Trading, LLC \$1,881.58 for natural gas purchases.
