Mayor, Bobby Allen, called the meeting to order at 6:00 pm. Those answering roll call were Ernest Allen, Leslie Swinerton, and Cozetta Johnson. Ronnie Wheeler was unable to attend this meeting. Also present were City Attorney Raymond Vincent, Public Works Director Jeff Choate, Police Chief Waylan Upchego, and Accounting Consultant Linda Woodruff, payroll clerk Jeremy Springer, Officer Cecil Harrall, fireman Jim Shelton, David Cottingham with DC Associates, Millie Vance Grant administrator, Travis Harrison and Jaycee with Harrison Construction, Melba Nance, Thomas Lewis, Chad Houchin, and Teresa Hicks.
