Bobby Allen will contact local citizens to request their approval to be appointed to a Board of Adjustments. Their duties will be to settle disputes between the zoning applicant and the zoning board.

The zoning for the Highway 281 corridor south of town will be discussed at the Planning and Zoning Board meeting.

Fire Chief, Jeff Choate, gave the council an update on what the fire department has been up to this past few months. The firefighters have been holding training classes at the station here in Geary for all types of fire rescues. Hinton, Calumet, and Greenfield have been attending these classes. These classes will help with the firefighter qualifications that are required of them. Ronnie Wheeler made the motion seconded by John Gregerson to approve the fire department report. Ronnie Wheeler had to leave at 7:15 pm.

Blaine County has been upgrading the 911 system to make emergency call more efficient. One of the upgrades is that all 911 calls will be dispatched out of Weatherford, Oklahoma. The fire departments are having issues with receiving the calls in a timely manner with the cell phone paging service. Jeff is currently using a system called E-dispatch. This system uses the tones of the cell phone to allow the notifications to be sent out quicker. He has a 30 day fee trial for this system and he is very satisfied with what he has seen up to date. The cost of this system is a one-time set up fee of \$199.00 and a monthly cost of \$129.00. The Rural Fire Department will pay the set-up fee and the first month fees. Jeff is asking the council to approve to add this to the 2017-2018 budget. Ernest Allen made the motion seconded by Cozetta Johnson to approve adding the E-dispatch system to the 2017-2018 budgets. Ayes: John Gregerson, Leslie Swinerton, Cozetta Johnson, and Ernest Allen. Nays: None.

After a lengthy discussion on updating the International Building Codes, it was decided to look into this further and possible have the Ordinances for these codes on the March agenda.

The annual Oklahoma Code Enforcement Association Spring Conference is March 23 and 24 at Quartz Mountain Arts & Conference Center in Lone Wolf, Oklahoma. The cost is \$125.00 per person with meals included and lodging fees of \$96.00. Jeff Choate and Lee Posey will not be able to attend this conference this year due to another conference that they must attend.
