The local oilfield activity is contributing to this increase.

Jeff Choate presented a report on the dilapidated structures hearings. Over 20 letters were mailed to home owners about the upkeep of their property. A hearing was conducted on these structures with all but 5 persons responding. 2 of the structures have been removed as of this date with others in the process of repairs to make the structures habitable. Continued progress will be monitored and reports made. No action was taken.

Jeff will look into getting quotes for the needed repairs for the chlorinator system and the chlorine room. He will also look into prices for a pool slide. No action was taken.

The fire department has recently acquired a "Grain Bin Rescue" kit in conjunction with Wheeler Brothers Grain. They have been training with this equipment so as to be prepared if it is ever needed. There were only 15 call outs for the month of January.

Craig Wright made the motion seconded by Trey Carter to approve the adoption of Ordinance 2018-01 to change the "Jake Brake" prohibited sighs to read "No loud braking devices". Ayes: John Burns, Tabbitha Kiener, Trey Carter, and Craig Wright. Nays: None.
